SUBJECT: Resolution #07-23: Interlocal Cooperative Agreement with the City of Mountlake Terrace for Preschool Services

RECOMMENDATION:

Approve Resolution #07-23, authorizing the Superintendent to enter into an Interlocal Cooperative Agreement with the City of Mountlake Terrace to provide preschool services.

BACKGROUND:

The district seeks to establish contracts with Community preschool agencies to provide preschool services for eligible special education students in a cooperative program involving district staff and local agencies providing preschool services. The district anticipates contracting for services for approximately three students.

RATIONALE:

RCW 28A.320 and RCW 39.34, the Interlocal Cooperative Act, permit the District to establish interlocal cooperative agreements with other governmental agencies. This agreement provides the framework for a cooperative program for preschool services.

AUTHORIZE INTERDISTRICT COOPERATIVE AGREEMENT  
WITH THE CITY OF MOUNTLAKE TERRACE

WHEREAS, RCW 39.34, the Interlocal Cooperative Act, provides for interlocal cooperation between governmental agencies;


WHEREAS, the City of Mountlake Terrace agrees to provide certain educational services to the District, specifically preschool services for special education students in cooperation with the district special education preschool program.

NOW THEREFORE, BE IT RESOLVED by the Board of Directors of the Edmonds School District No. 15, Snohomish County, as follows:

1. That a joint cooperative by and between Edmonds School District No. 15 and the City of Mountlake Terrace be formed as an interlocal cooperative for the purpose of providing preschool services for member districts.
2. That the Superintendent or designee of Edmonds School District No. 15, Snohomish County, Washington, is hereby designated as representative to the interlocal cooperative, and the Superintendent or designee is further authorized to execute and implement the requisite agreement or agreements to accomplish this purpose.
