AUTHORIZE INTERLOCAL COOPERATION AGREEMENT  
WITH LAKE WASHINGTON INSTITUTE OF TECHNOLOGY

---

WHEREAS, RCW 39.34, the Interlocal Cooperation Act, provides for interlocal cooperation between governmental agencies;

WHEREAS, Lake Washington Institute of Technology, District No. 26, King County, Washington agrees to permit students of the District to use their vocational-technical education program, Lake Washington Technical Academy, and such basic education services as are necessary to complete simultaneously the high school diploma;

WHEREAS, the District wishes to use the vocational-technical education program, Lake Washington Technical Academy, a program located at Lake Washington Institute of Technology, to support the educational requirements and goals of the District;

NOW THEREFORE, BE IT RESOLVED by the Board of Directors of the Edmonds School District #15, Snohomish County, as follows:

1. That an interlocal cooperation agreement be formed between the Edmonds School District #15 and Lake Washington Institute of Technology for the purpose of permitting use of Lake Washington Technical Academy for training by the District's students.
2. That the Superintendent or designee of Edmonds School District #15 is hereby designated as representative to the interlocal cooperation agreement, and the Superintendent or designee is further authorized to execute and implement the requisite agreement or agreements to accomplish this purpose.

INTERLOCAL AGREEMENT FOR COOPERATIVE EDUCATIONAL SERVICES  
FOR VOCATIONAL-TECHNICAL AND BASIC EDUCATION

2015-2020

This agreement is hereby entered into by and between the Lake Washington Institute of Technology, District No. 26, King County, Washington, hereinafter referred to as the college, and the Washington State School district listed below, hereinafter referred to as the "resident district":

EDMONDS SCHOOL DISTRICT NO. 15

The purpose of this agreement is to utilize interlocal cooperation, as authorized by RCW 28A.150.275, RCW 28B.50.533, WAC 392-121-187, WAC 392-700, or any new statutory authority that may be created during the period of this agreement, to provide vocational-technical educational programs not otherwise available and to avoid duplication of specialized programs and facilities. These objectives will be achieved by the following described cooperative program:

The general purpose of this cooperative shall be to provide vocational-technical educational programs and services, and such basic education services as are necessary to complete the high school diploma, to high school students of the resident district at Lake Washington Technical Academy (LWTA) is accredited as a special purpose high school through AdvancED. Students earn high school and college credit.

The cooperative is expected to serve an average of 350 full-time equivalent students annually during the period 2015-2020 from some or all of the 32 resident districts that historically have sent students to the Lake Washington Technical Academy. Students must complete our variance for attendance release, signed by your designated school district official, on enrollment and annually for each school year. A copy will be returned to the school district.

The college will not bill the resident district for any excess costs incurred in providing vocational-technical or basic education programs and services to high school students of the resident district. The college will directly bill the Office of the Superintendent of Public Instruction pursuant to the provisions of RCW 28A.150.275, and will provide monthly reports to the resident district in accordance with WAC 392-121-187, WAC 392-700, or any new statutory authority that may be created during the period of this agreement. This agreement does not apply to Running Start enrollments.

The resident district will not bill the college for any costs incurred as a result of the college providing vocational-technical or basic education programs and services to high school students of the resident district. In order to avoid any claim in excess of one full-

time equivalent student, the resident district will notify the college in advance of any concurrent enrollment of resident district students participating in LWTA.

The resident district retains all responsibility for any special education services needed by resident district students attending LWTA. Students who withdraw or are expelled or dismissed will be referred back to the resident district.

Each party to this agreement shall be responsible for its own acts and/or omissions and those of its officers, employees and agents. No party to this agreement shall be responsible for the acts and/or omissions of entities or individuals not a party to this agreement.

Each party to this agreement acknowledges that entering into this interlocal cooperative arrangement may result in financial commitments by other parties to this agreement. Each party further acknowledges that while the agreement is for the term provided herein, program development is continuous and long-range planning is a requisite, and entering into this agreement may carry implications for succeeding school years. Therefore, each party agrees to notify the other by April 15 if the party decides to terminate the agreement in any year prior to its expiration. The parties agree this agreement may be terminated at any time with the consent of the other party.

This agreement is for a five year term of 2015-2020 and was approved by the resident district Board of Directors.

APPROVAL OF INTERLOCAL COOPERATION AGREEMENT BETWEEN LAKE WASHINGTON INSTITUTE OF TECHNOLOGY DISTRICT NO. 26, KING COUNTY, WASHINGTON FOR STUDENTS TO USE THE VOCATIONAL-TECHNICAL EDUCATION PROGRAM FOR THE 2015-2020 SCHOOL YEARS PER RESOLUTION NO. 15-10.

**Recommendation**

It is recommended that the Board of Directors approve the Interlocal Cooperation Agreement regarding the Lake Washington Academy through Lake Washington Institute of Technology per Resolution Number 15-10.

**Background**

Lake Washington Technical Academy offers eligible high school junior and senior students, ages 16 to 20, the opportunity to earn a high school diploma while working to complete a two-year technical college degree. Lake Washington Technical Academy is accredited by the Northwest Association of Schools and Colleges and is a full-time special purpose high school program located on the campus of Lake Washington Institute of Technology in Kirkland, Washington. The program enrolls 300-350 students annually representing 30 regional school districts.

Approval of this interlocal cooperation agreement renews an ongoing agreement which allows Edmonds School District students to access this program. The Lake Washington Technical Academy enrolls an average of 11 students annually from the Edmonds School District.
