

MEMORANDUM OF UNDERSTANDING

This MEMORANDUM OF UNDERSTANDING is supplemental to the AGREEMENTS by and between EDMONDS SCHOOL DISTRICT #15, hereinafter referred to as the DISTRICT and the CUSTODIANS, FOOD SERVICE DRIVERS AND WAREHOUSE EMPLOYEES unit and the MAINTENANCE TRADES EMPLOYEES SERVICE EMPLOYEES' INTERNATIONAL UNION LOCAL #925 and ADMINISTRATIVE ASSISTANTS, hereinafter referred to as the ASSOCIATION.

The DISTRICT and the ASSOCIATION agree that this MEMORANDUM OF UNDERSTANDING is hereby supplemental to the 2013-2017 CUSTODIANS, FOOD SERVICE DRIVERS AND WAREHOUSE EMPLOYEES Collective Bargaining Agreement and to the 2013-2017 MAINTENANCE TRADES EMPLOYEES Collective Bargaining Agreement and ADMINISTRATIVE ASSISTANTS' Meet and Confer Agreement. The parties hereby agree to the following:

The CUSTODIANS, FOOD SERVICE DRIVERS AND WAREHOUSE EMPLOYEES unit has requested to join with the MAINTENANCE TRADES EMPLOYEES unit and ADMINISTRATIVE ASSISTANTS for insurance pooling. The MAINTENANCE TRADES EMPLOYEES unit and the ADMINISTRATIVE ASSISTANTS have agreed.

Therefore, CUSTODIANS, FOOD SERVICE DRIVERS AND WAREHOUSE EMPLOYEES unit, MAINTENANCE TRADES EMPLOYEES unit and ADMINISTRATIVE ASSISTANTS will become one insurance pooling group.

This MEMORANDUM OF UNDERSTANDING shall take effect September 1, 2017 and shall remain in effect until August 31, 2018.


