WALK-IN & HAVE YOUR TAXES PREPARED IN PERSON FOR FAMILIES & INDIVIDUALS

Walk into a tax site and *ask about open time slots*. Returns are prepared on the hour, each hour sites are open. Please arrive 10 minutes before the hour to check in. Wait times will vary, and there is no guarantee of availability.

USE MYFREETAXES.COM AND FILE ON YOUR OWN TIME

MyFreeTaxes is an online self-tax preparation filing service that is completely free, safe, and secure. It can be accessed either from a desktop or a mobile device, making it easy to file anytime and anywhere. Find out more at myfreetaxes.com.

ELIGIBILITY REQUIREMENTS

- Household income of \$66,000 a year or less
- No rental income, no military income, and no business losses
- Business expenses totaling less than \$25,000 in 2019

SERVICES

Our Free Tax Prep Program focuses on making sure families access the Earned Income Tax Credit (EITC), Child Tax Credit, and other credits important to young children and their families with low income.

TRAINED, FAST, FREE



TRAINED

Certified by the IRS, our volunteers go through rigorous training and extensive testing to make sure tax returns are prepared correctly and are submitted securely.



FAST

Tax returns are filed electronically, ensuring quick turnaround times for receiving refunds, if eligible, and at no cost.



FREE

Did you know that some paid preparers charge upwards of \$400 to prepare returns? We provide a free alternative to other places that charge you a high fee to get your refund. Why pay for tax preparation when you can get it done for free? You earned it—it belongs in your pocket!

WHAT TO BRING

**We cannot prepare your return unless you bring ALL required documentation with you.

SPOUSE

If filing jointly, *both* filer and spouse must be present

PHOTO IDs FOR TAXPAYER & SPOUSE

Must be government-issued

SOCIAL SECURITY CARDS OR ITIN NUMBERS

For every person listed on your return

ALL TAX FORMS

(W-2s, 1098s, 1099s, etc.)

COPY OF LAST YEAR'S RETURN

BANK ACCOUNT & ROUTING NUMBERS

For direct deposit
